# Q3/2025: Profitability affected by exceptional events, outlook reduced

## Q3/2025

- Charles Héaulmé started as President and CEO on August 11, 2025
- Net sales decreased by 11% and were EUR 99.8 million (Q3 2024: 111.6)
- Comparable EBITDA increased to EUR 3.4 million (3.3)
- Cash flow from operations was EUR 15.7 million (-2.6)

## 1-9/2025

- Net sales decreased by 8% and were EUR 317.1 million (Q1-Q3 2024: 343.8)
- Comparable EBITDA decreased to EUR 10.7 million (12.8)
- Cash flow from operations was EUR 5.2 million (-2.6)

Performance in Q3 was significantly affected by exceptional events at two US factories, which reduced our 2025 outlook. Our cost savings program has gained traction and we are on track to implement the majority of actions by year end.



## Francois Guetat joins Suominen as COO

- Suominen has appointed Francois Guetat, M.Eng., as Chief Operating Officer, and member of Suominen Leadership Team as of November 3, 2025
- He brings over two decades of global experience in operations, supply chain, and manufacturing excellence
- Most recently, he served as SVP of Integrated Supply Chain at Kalmar, where he led business across sourcing, manufacturing, logistics and strategy
- His leadership has been shaped by 22 years at Volvo, where he held key roles in Sweden, USA, and Poland
- Suominen's Chief Operating Officer Darryl Fournier has decided to leave the company to pursue other professional endeavors. He will continue with Suominen until end of January 2026, focusing on strategic projects.



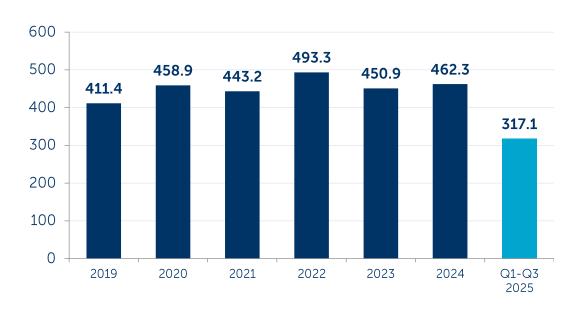

- In Q3/2025, net sales decreased by 11% and were EUR 99.8 million (111.6).
- Sales volumes decreased but sales margins increased.
- Currency fluctuations had a negative impact on net sales in Q3/2025, EUR -3.7 million.
- Share of new products was 30% in Q3/2025.

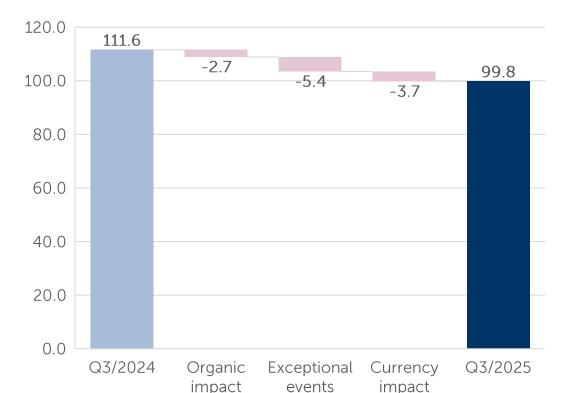




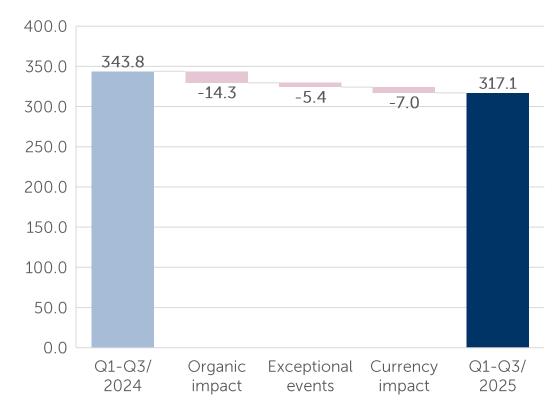


## Net sales reduction mostly linked to Q3 exceptional incidents

## Q1-Q3/2024 vs. Q1-Q3/2025, EUR million

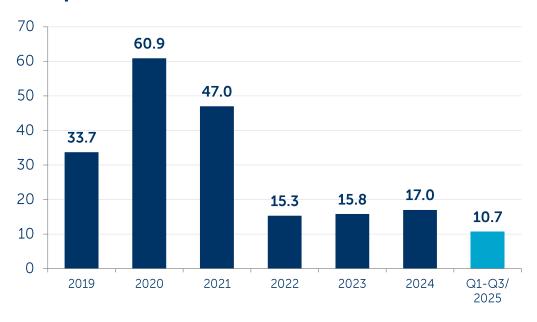


- Organic impact includes volume, price and mix impact.

- Currency impact is mainly related to EUR-USD.

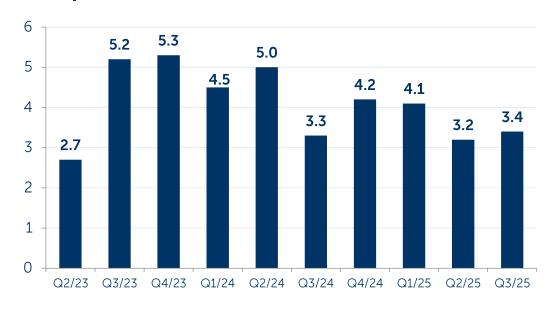


## Comparable EBITDA affected by exceptional incidents during Q3

## Comparable EBITDA, EUR million



- Comparable EBITDA increased in Q3/2025 to EUR 3.4 million (3.3).
- Negative effect of lower sales volumes on comparable EBITDA are partly offset by lower raw material prices.
- Negative impact of incidents at US plants on EBITDA amounted EUR 2.8 million.
- The impact from currency fluctuations on EBITDA was EUR +0.3 million.

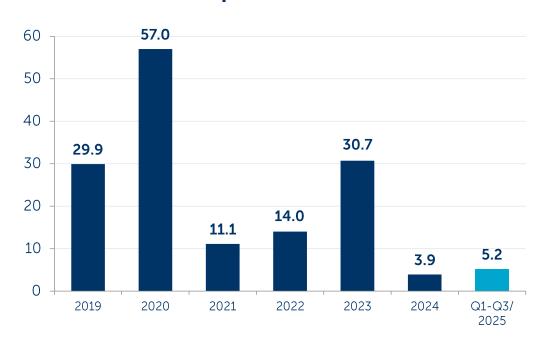

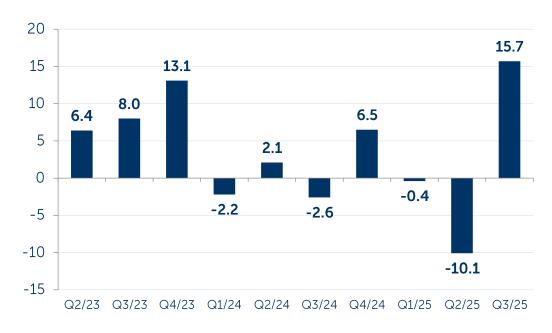

## Cash flow from operations, EUR million



- Cash flow from operations amounted to EUR 15.7 million (Q3/2024: -2.6) for July-September and EUR 5.2 million (-2.6) for January-September.
- Change in net working capital in the cash flow from operations was EUR 13.9 million (-2.7) for July-September and EUR 0.9 million (-9.7) for January-September.

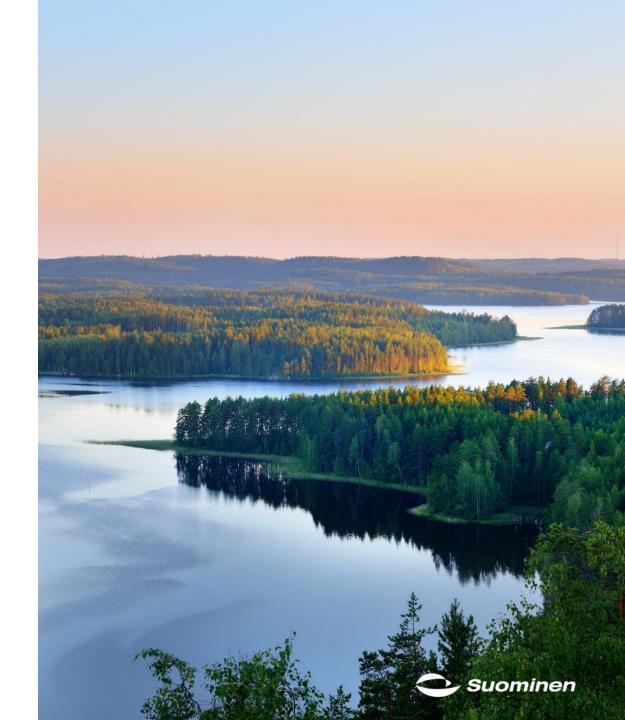




# PROGRESS IN COST SAVING PROGRAM

# Cost-saving program to secure profitable growth

- In May 2025, Suominen announced a cost-saving program to secure profitable growth and ensure long-term competitiveness.
- The program is expected to result in savings of approximately EUR 10 million. Savings are planned to realize over the next 24 months.
- In June we announced that the program led to a decrease of approximately 60 positions globally. On top of that, we reduced the number of contractor roles.
- Saving actions implementation has proceeded well during the third quarter of 2025 and we are on track to implement majority of the actions by the end of the year.





# OUTLOOK

## Revised outlook for 2025

• Suominen communicated on October 15, 2025, a change in its outlook. The company now expects that its comparable EBITDA (earnings before interest, taxes, depreciation and amortization) in 2025 will be lower compared to 2024. In 2024, Suominen's comparable EBITDA was EUR 17.0 million.

## • Previous outlook:

In its Financial Statements release for 2024, published on March 5, 2025, and in its half-year report published on August 7, 2025, Suominen estimated that its comparable EBITDA (earnings before interest, taxes, depreciation and amortization) in 2025 will improve from 2024.
